## PARENT AGREEMENT - 2020/2021 WAIVER

I certify that my child is in good health and I understand that participation in classes involves physical movement and execution. I agree to provide medical insurance for my child and family. If my emergency contact cannot be reached, I give permission to the staff of MF Dance USA to render aid or to act in my behalf to obtain emergency medical treatment for the student for any illness or injury that may occur while attending classes, rehearsal, performances or on the premises.

I knowingly and willingly consent to have my child participate in dance classes with MF Dance USA during the global COVID-19 pandemic. I confirm that my child and members of my household have not, in the past 14 days, had any symptoms of COVID-19, nor will I send my child to MF Dance USA if they are showing any symptoms. I agree to the below studio guidelines MF Dance USA has put in place and understand there are no exceptions to the rules for myself or my dancer.

I understand that I must have a charge card on file to be used for tuition and costumes. I understand that tuition is due on the 1<sup>st</sup> of every month and that it will be automatically taken out of my account on the 1<sup>st</sup> of the month. I understand that if for some reason my payment does not go through and I do not make my payment by the 10<sup>th</sup> of the month my card will be run again. If my card does not go through at that time, I agree to pay the non-refundable \$15.00 late fee. I understand that a current/unexpired credit card MUST always remain on my account, if not my child/children can be removed from classes.

Non-refundable costume deposits will be taken out on the 15<sup>th</sup> of October (\$50 for every class that your child is registered). If not paid for by the 25<sup>th</sup> of October, a non-refundable \$15 late fee will be applied to your account. Costume balances will be charged to your account in January. An email will be sent to you with the due date and the amount of the balances. They will be automatically charged to your card on file on the due date. If not paid for within 10 days of the due date, your account will be charged a non-refundable \$15 late fee.

In addition, I understand that I am registering for September-June and if I choose to drop a class, after January 1<sup>st</sup>, there will be no refund due to me. However, I may drop a class and receive a prorated refund prior to January 1<sup>st</sup>. I understand that if I drop a class I am still responsible for the costume balance if the costume deposit has already been made. If I do choose this option to drop a class, I will notify the office in writing by mail or email on or before January 1<sup>st</sup>. If I fail to do so, I understand that I will be registered in the class and charged until I notify the office of the withdrawal in writing. After January 1<sup>st</sup>, there are NO refunds or credits given.

I understand that failure to pay tuition, late fees or miscellaneous charges may result in termination of my child's participation in their class(es) until such a point that my account is made current.

I understand that I am committing to the entire recital weekend. Conflicts will not be able to be accommodated.

I understand that MF Dance USA does not issue refunds for any reason, including missed classes due to illness, vacation, religious observance, inclement weather, or withdrawal. Any missed classes can be made up in another age appropriate class during the season (up until February when recital preparation begins), subject to enrollment and availability. Refunds will not be given for costumes, tights, or any other items purchased at MF Dance USA.

**RELEASE OF LIABILITY: As the legal parent or guardian, I release and hold harmless Michelle Ferraro's Dance USA, its owners and operators from any and all liability, claims, demands, and causes of action whatsoever, arising out of or related to any loss, damage, or injury, including death, that may be sustained by the participant and/or the undersigned, while in or upon the premises or any premises under the control and supervision of Michelle Ferraro's Dance USA, its owners and operators or in route to or from any said premises. I, for myself and my family, release Michelle Ferraro's Dance USA from any liability in reference to COVID-19.
